<u>DMA Audit</u>: Kristen Hunt, Plante Moran, reported. Kristen reviewed the <u>DMA audit</u> highlights (hand-out). This audit resulted in an "unmodified opinion;" <u>the highest possible audit opinion.</u> All funds ended the year with a positive fund balance, except for Highway Safety had a deficit of (\$50,959), which was due to a GASB 33 timing difference. A federal program audit was not required. There was a financial statement finding related to journal entries that were required during the audit, related to closing out the old DRANO funds and consolidating the other DMA program funds. Jim Perry thanked Kristin and her staff for their support. Motion by Mayor Guzzi, supported by Councilwoman Lamb, to accept the DMA Audit as presented. The motion passed unanimously.
